



AGREEMENT FOR COLLABORATION, ACADEMIC AND RESEARCH INNOVATION

Between Monark University (MU) and Princonser University (PU)

PREAMBLE

Monark University (MU), a public research institution based in Ahmedabad, India, represented by its President Dr. Hasmukhbathi Goswami and **Princonser University (PU)**, founded and represented by Prof. Dr. Fidel Gutiérrez Vivanco, President and creator of the Universal Princonser Scientific Method, CONSIDERING that both universities share the mission of integrating science, philosophy, and universal wisdom for the progress of humanity; RECOGNIZING that MU represents the material component — its institutional structure, faculties, and academic and human resources — while PU contributes the energetic component — the Princonser Method and its Universal Intelligences — thus establishing a perfect balance in accordance with the Universal Essence (E-M); AGREE to enter into this Agreement for Collaboration, Academic and Research Innovation, under the following provisions:

ARTICLE 1. OBJECTIVE

To establish a strategic alliance for the joint development of educational innovation programs, scientific research, universal intelligence, ethical sustainability, and a culture of peace, applying the fundamentals of the Universal Princonser Scientific Method.

ARTICLE 2. AREAS OF COOPERATION

1. Creation of a Princonser Research Institute at Monark University (MU)
2. Princonser Universal Intelligence: Integrate the Princonser algorithms with **Monark University (MU)**'s AI infrastructure.
3. Educational Innovation and Universal Curriculum: Incorporate the Princonser Method into academic curricula and researcher training.



4. Sustainable Development and Business Ethics: Apply the project The Ethical Formula within MU's sustainability programs.

5. Culture of Peace and Universal Wisdom: Promote international forums and joint publications.

ARTICLE 3. COMMITMENTS OF THE PARTIES

3.1 Monark University (MU) shall:

- Implement the establishment of the Princonser Research Institute at MU.
- Provide infrastructure, faculties, laboratories, and academic resources.
- Appoint an institutional coordinator for the execution of this agreement.
- Integrate the universal vision of the Princonser Method into its research and teaching programs.
- Monark University will develop course programs, master's degrees, doctorates, and postdoctoral studies based on the innovation of the Princonser Method.

3.2 Princonser University (PU) shall:

- Contribute the intellectual and methodological energy of the Universal Princonser Scientific Method and its Universal Intelligences.
- Train UM researchers in its application.
- Supervise the scientific and universal coherence of all joint projects.
- Princonser University will provide scientific research advisory services and academic support for the development of study programs and research

ARTICLE 4. JOINT RESEARCH CENTER

The **Monark University (MU) –Princonser Center** for Universal Science is hereby established as an interdisciplinary innovation hub that will act as the nucleus of E-M integration. It shall be directed by a Binational Committee for Scientific Coordination, responsible for planning and evaluating academic and technological actions.

ARTICLE 5. INTELLECTUAL PROPERTY



1. The intellectual property of the Universal Princonser Scientific Method, its algorithms, and Princonser Universal Intelligences belongs exclusively to Princonser University (PU).
2. Results and materials developed jointly shall be jointly owned, with PU recognized as the original holder of the methodology and **Monark University (MU)** as the co-producer of the material manifestation of the projects.
3. All publications, patents, or creations arising from this collaboration shall explicitly acknowledge the intellectual authorship of the Princonser Method and the institutional participation of both Institutions.

ARTICLE 6. UNIVERSAL BALANCED FINANCING

In coherence with the Universal Essence, financing shall be based on the energy-matter (E-M) equilibrium:

- Princonser University contributes energy, represented by the Princonser Method, the Princonser Universal Intelligences, epistemological vision, and philosophical-scientific direction.
- **Monark University (MU)** contributes matter, represented by the university itself — its faculties, schools, infrastructure, and human and administrative resources. Both forces complement each other to ensure the project's self-sustainability without financial subordination, reflecting the Law of Dependence and the Law of Universal Interaction:

Each party may mobilize external funds, always under joint and proportional management, preserving the E-M unity principle:

ARTICLE 7. DISSEMINATION AND PUBLICATION

Both institutions agree to disseminate the results through books, journals, documentaries, and digital platforms highlighting the **Monark University (MU)** - Princonser Alliance, promoting universal education and planetary wisdom.

ARTICLE 8. DURATION AND RENEWAL

This agreement shall remain in force for five (5) years, automatically renewable by mutual consent. It may be reviewed every two years to evaluate its progress and expand the areas of cooperation.

ARTICLE 9. SETTLEMENT OF DISPUTES

Any differences shall be resolved through fraternal dialogue and philosophical-academic conciliation. Should discrepancies persist, the matter shall be referred to international university arbitration guided by principles of ethics and universal wisdom.

ARTICLE 10: SPECIFIC AGREEMENTS, LICENSING REGIME AND MUTUAL BENEFIT

10.1. Principle of Joint Manifestation. The Parties recognize that the true integration of Energy (E) and Matter (M) requires concrete practical manifestations. Therefore, any operational collaboration derived from the general principles of this Memorandum of Understanding shall be governed by Specific Agreements negotiated in good faith and signed by both Parties.

10.2. Licensing Regime for PU's Intellectual Property.

10.2.1. Princonser University (PU) grants Monark University (MU) a non-exclusive, non-transferable, royalty-free license to use the Universal Princonser Scientific Method, its algorithms and principles ("the Methodology"), solely for the execution of the projects and programs specifically described and approved in the Specific Agreements under this framework.

10.2.2. This license is limited to the territorial scope of MU in India and to the duration of the specific project. Any use, adaptation, modification, or extension of the Methodology beyond what is stipulated in a Specific Agreement shall require new negotiations and a separate licensing agreement.

10.3. Content of Specific Agreements. Each Specific Agreement shall clearly define:

- a) The concrete objectives and deliverables of the project.
- b) The material and human resources to be contributed by each Party.
- c) The detailed timeline.

- d) The governance and supervision mechanisms.
- e) The treatment of generated Intellectual Property.
- f) Funding and Benefit-Sharing Mechanisms: Including the administration of external funds, the distribution of any surplus, and/or any compensation or exchange of services reflecting the value of the Energy (PU) and Matter (MU) contributions.

10.4. Preferential Rights and Future Development.

10.4.1. Acknowledging that the innovative Energy of PU must find multiple manifestations for its full realization, MU grants PU a first right of negotiation for, under mutually agreed terms:

- a) Adapting, offering, and granting degrees for the joint study programs (courses, master's degrees, doctorates), in virtual or semi-presidential modality, for the territory of Latin America and other non-Indian markets.
- b) Using the curricular designs, pedagogical materials, and research results generated within the framework of the alliance, as part of PU's academic portfolio for purposes of accreditation, institutional improvement, and capability demonstration.

10.4.2. The commercial, licensing, and operational conditions for exercising these preferential rights shall be established in a dedicated Specific Agreement, ensuring a fair and balanced benefit for both institutions.

10.5. Purpose. This article aims to ensure that the E-M alliance translates into a sustainable collaboration, where the value generated by the synergy circulates and feeds back to both Parties, securing the perpetuation of the flow of innovation and the material realization of universal wisdom'

ARTICLE 11. FINAL PROVISIONS

This agreement is executed in two counterparts of equal value, in Spanish and English, in the city of Kuala Lumpur, on the 20th day of November, 2025.
